RE: Amendment to Product Supply Agreement (Account # 317454)

Dear Mr. Murray,

This letter will serve as an Amendment to the Product Supply Agreement dated 14 August 2001 as Amended on 16 March 2006, 24 March 2010 and 11 February 2015 (the "Agreement"), between Rockdale County, Political Subdivision of State of Georgia ("Buyer") and Air Products and Chemicals, Inc. ("Seller"). For the purposes of this Amendment this document shall be defined as the "Agreement".

Buyer and Seller have agreed to amend the Agreement as follows:

1. The Initial Term of the Agreement shall be extended through February 11, 2023.
2. Buyer's Hazmat Charge shall be billed monthly and shall not exceed (1) Hazmat Charge per month.
3. Upon Signature of this Amendment the Unit Price shall be reduced to \$6.80/1000scf and the Monthly Charge shall be reduced to \$1,339 and both shall be held Firm through 10/31/2019.
4. The Estimated Monthly Volumes shall be changed to 575,000 SCF.

Except as expressly set forth herein all other terms and conditions of the Agreement shall remain in full force and effect.
