ALL WORKERS MUST ATTEND TRAINING CLASS

All assigned Poll Workers are required to attend a **2½-3 HOUR** training class required for all Poll Workers prior to each election. Poll Workers attending these classes are paid \$10.00. **Training class consist of hands-on training.**

REQUIREMENTS

Poll Workers

Must possess the qualifications as set out in Section 21-2-92: A Poll Officer shall be judicious, intelligent, and upright citizens of the United States, residents of the County in which they are appointed, 16 years of age or over, and shall be able to read, write, and speak the English language. No Poll Officer shall be a candidate for an election, an elected official, or close relative of candidates, including the candidate's parent, spouse, child, brother, sister, father-in-law, mother-in-law, son-in-law, daughter-in-law, brother-in-law, or sister-in-law where the candidate's name appears on the ballot. However, a Poll Officer may serve in a primary in which he seeks election to a political party office unless prohibited by the rules of the political party conducting the primary.

NOTE: Ga. Election Code Section 21-2-8 states that no person convicted of a felony shall serve as a poll officer unless his civil rights have been restored.

CLERK/GREETER \$105.00

1. Must be a resident of Rockdale County;
2. Must be at least 16 years of age;
3. Must have successfully attend and complete training class conducted by Rockdale County Board of Elections and Registration before each election.
4. Must assist with setting up polling place.

ASSISTANT MANAGER \$130.00

1. Must be willing to serve as Manager, if requested by the Elections Office.
2. Must have served as a Clerk in at least Two elections in Rockdale County.
3. Must have your own transportation to pick up election supplies and/or equipment and bringing same to check-in center, and be able to lift 20 lbs.
4. Must accompany Poll Manager on election night to drop off ballots at check-in center.
5. Must assist with setting up polling place.
6. Must have successfully completed training class conducted by Rockdale County Board of Elections and Registration before each election.

CHIEF MANAGER \$200.00

1. Must be a high school graduate or equivalent
2. Must have served in at least Two elections in Rockdale County as an Assistant Manager.
3. Must have successfully completed training class conducted by Rockdale County Board of Elections and Registration before each election.
4. Must have your own transportation to pick up election supplies and/or equipment and bring same to check-in center and be able to lift 20 lbs.
