

ATTENTION

A Judicial Emergency has been declared by both the Supreme Court for the State of Georgia and the Superior Court of Rockdale County. The nature of the emergency is the continued transmission of the Coronavirus/COVID-19 throughout the State and the potential infection of those who work in or are required to appear in our Court.

The Rockdale County Juvenile Court remains OPEN to address essential Court functions. However, court staff and employees will be working and carrying on the day-to-day functions of the Court from home. During this time, the Juvenile Court will continue to hold delinquency detention hearings, dependency emergency removal matters and emergency matters. However, to the extent that the hearings mentioned above are held, they will be held by videoconference to limit the risk of exposure to the public.

Until further notice, all deadlines or other time schedules or filing requirements imposed by otherwise applicable statutes, rules and regulations and court orders including but not limited to any: (1) statute of limitation; (2) time within which to issue a warrant; (3) time within which to try a case; (4) deadline or other schedule regarding the detention of a juvenile; (5) time within which to serve a party; (6) time within which to appeal or seek a right to appeal; (7) and such other legal proceedings as determined to be necessary are hereby SUSPENDED until April 13, 2020 at 11:59 p.m. or until such time as the Judicial Emergency Declaration has been lifted.
