CONTRACT AMENDMENT NO. 2 TO THE AGREEMENT FOR PROVIDING FIRE PROTECTIVE CLOTHING DATED NOVEMBER 14, 2017

This CONTRACT AMENDMENT, made and entered into by and between ROCKDALE COUNTY, GEORGIA, hereinafter called the "County", and North America Fire and Equipment Company Inc., (NAFECO) hereinafter called the "Contractor", shall be incorporated into and become a part of the original Agreement cited immediately above.
