Rockdale Accountability Courts (DUI, Adult Drug and Resource), established under State and Superior Court of Rockdale County, were created for the purpose of helping individuals who suffer from mental illness and/or a substance use disorder related to their legal involvement, thus reducing their likelihood of recidivism.

Rockdale Accountability Courts seek to utilize funding for a Part-time Peer Support Specialist to enhance services and provide social support throughout different stages of recovery.

It is recommended that funding in the amount of \$21,600.00 be accepted.

CONTRACT AMENDMENT NO. 2 to the
Subrecipient Agreement dated May 14, 2019

This contract amendment, made and entered into by and between ROCKDALE COUNTY, GEORGIA, hereinafter called the "County", and WALTER NUNNALLY, hereinafter called the "Subrecipient", shall be incorporated into and become a part of the original Agreement cited immediately above.

NOW THEREFORE, the County and the Subrecipient agree to amend the Agreement as follows:

Page 3 of 7, Section 5, PAYMENT, delete first sentence "The County shall pay Subrecipient \$13.00 per hour for Peer Support Services provided to County" and replace with "The County shall pay Subrecipient \$15.00 per hour for Peer Support Services provided to County."

All other terms and conditions shall remain in effect in accordance with the Agreement referenced in this Amendment.


