### Section 4: Employee Fees

Rentals are for employee's personal usage only and not transferable to other family members or groups. Employee must pay for, be on premises and be the responsible party for the entirety of the event. Payment is due at time of booking. Available rates apply to reservations for any type of event excluding weddings at Costley Mill. Costley Mill wedding packages are not discounted.

All employee fees noted are for current regular part time or full-time employees of Rockdale County Government. If employee leaves employment with the County, they will have 30 days to pay non-employee fee for any ongoing memberships or future facility reservations. Failure to do so, will result in loss of membership or event reservation.

**Section 4: Senior Services**

The annual membership fee for the Olivia Haydel Senior Center is \$25 for Rockdale County residents aged 60+ years. Out of county memberships for the Senior Center are \$50 per year. Scholarships may be requested for low-income in-county persons.

**Section 5: Facility Rental Rules and Regulations**

Any person who utilizes any facility maintained by Rockdale County General Services Department shall comply with Facility Rental Rules and Regulations. A copy of Facility Rental Rules and Regulations shall be maintained at Johnson Park Recreation Center.

The County reserves the right to delete, modify, amend, or terminate this policy at any time with or without prior notice.


