**RFQ #22-20** is hereby amended as follows:

**1. Below are questions received and corresponding answers:**

**A. Question:** If geotechnical, survey, or electrical services are needed for a Category 1-3 project should we plan on using the firms selected for Categories 4-7 for our on-call work or can we select on own subconsultants?

**Answer:** We would like the sub-consultants to be firms selected to perform work in specific categories.

**B. Question:** Per Addendum No. 1, Item E, "Electronic signature and initials are acceptable." Could you please confirm that electronic signatures are acceptable throughout the entire proposal and for both the Original and the Copies, without any wet signatures needed at all?

**Answer:** For RFQ #22-20, the electronic/scanned/photocopied signatures shall be as valid as the original.

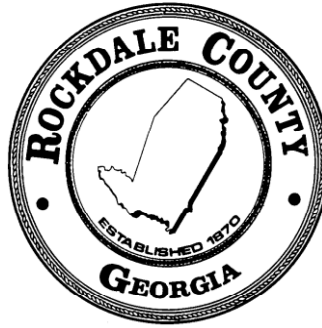
**C. Question:** Per Addendum No. 3, Item E, "Question: Please confirm that project examples should be placed in Tab 6. Supporting Information as noted on page 11. Tab 6, second bullet, and not in Tab 3. Firm Qualifications. Answer: "Yes, that is correct." On RFQ Page 10, Tab 3: FIRM QUALIFICATIONS states "Similar projects by service category, location, and total project cost, which have been performed by the firm. Include three (3) projects per category for which your firm wishes to be qualified." Could you please clarify that these are the projects that need to go in Section 6? No project descriptions should be in this section at all?
