## COUNTY OF ROCKDALE

A RESOLUTION ALLOWING FOR THE CREATION AND APPOINTMENT OF AN ADDITIONAL LAW CLERK FOR ROCKDALE COUNTY, GEORGIA, AND THE ROCKDALE JUDICIAL CIRCUIT BY THE ROCKDALE COUNTY SUPERIOR COURT CHIEF JUDGE AND FOR THE ALLOCATION OF SUPPLMENTAL COMPENSATION FOR CERTAIN POSITIONS.

WHEREAS, the Board of Commissioners of Rockdale County, Georgia, and the Rockdale Judicial Circuit are devoted to the protection of and justice for all citizens of Rockdale County; and

WHEREAS, the Superior Court of the Rockdale Judicial Circuit has the authority to exercise original, exclusive, or concurrent jurisdiction, as the case may be, of all causes, both civil and criminal, granted to the pursuant to O.C.G.A. § 15-6-8; and

WHEREAS, each judicial circuit and Superior Court Chief Judge has the authority to employ such employees as necessary for the successful execution of the purpose of the office and to assign duties and fix titles pursuant to State law; and

WHEREAS, personnel who are employed by the Rockdale Judicial Circuit's Superior Court Office shall serve at the pleasure of that office, and shall be compensated by the State of Georgia with additional compensation through a County supplement in a manner and amount as set forth by the Superior Court Chief Judge with the approval of the Rockdale County Board of Commissioners; and,

WHEREAS, the Superior Court Chief Judge desires to create an additional position of Law Clerk with an effective date of July 1, 2021, to serve at the pleasure and discretion of the Superior Court and handle assignments and responsibilities as assigned within this position; and,

WHEREAS, the Superior Court Chief Judge desires to allocate a County Supplement amount of \$12,900 for the newly created Law Clerk position; and,

WHEREAS, the Superior Court Chief Judge desires to increase County Supplement funds to the existing Law Clerk position from the amount of \$19,900 to a new supplement amount of \$26,900.

NOW, THEREFORE, BE IT RESOLVED and authorized by the Board of Commissioners of Rockdale County, Georgia, that the additional position of Law Clerk of Rockdale County, Georgia and the Rockdale Judicial Circuit shall be created.

**BE IT FURTHER RESOLVED** that the newly created Law Clerk position be allocated a county supplement amount of \$12,900.
