RESOLUTION OF THE BOARD OF COMMISSIONERS OF ROCKDALE COUNTY, GEORGIA, APPROVING A PRIVATE ACTIVITY BOND TRANSACTION TO ASSIST IN FINANCING TERRACES AT FIELDSTONE, AN \$83,000,000, APPROXIMATELY 316 MULTIFAMILY HOUSING RENTAL DEVELOPMENT LOCATED IN ROCKDALE COUNTY

WHEREAS, the Development Authority of Rockdale County (the "Authority") has considered the application of The Affordable Housing Preservation Corporation, a Florida nonprofit corporation (the "Borrower"), requesting the Issuer's assistance in the financing, in whole or in part, the cost of the acquisition and rehabilitation of approximately 316 multifamily housing rental units located at 50 Loch Haven Drive SE, Conyers, Georgia 30013 and currently known as Terraces at Fieldstone, said project to consist of certain buildings, structures, machinery, equipment and related real and personal property (the "Project") for the benefit of the Borrower, through the issuance of up to \$83,000,000 in aggregate principal amount of its tax-exempt revenue bonds, in one or more series (the "Bonds"); and

WHEREAS, the Issuer by its designated Hearing Officer, held a public hearing with respect to such proposed financing of the Project on November 4, 2021, and no adverse comments were received; and

WHEREAS, the Board of Commissioners of Rockdale County, Georgia (the "Board") has been informed that pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), provides that the governmental unit having jurisdiction over the issuer of private activity bonds and over the area in which any facilities financed with the proceeds of such private activity bonds is located shall approve the issuance of such bonds solely for purposes of such section of the Code; and

WHEREAS, the Issuer issues its revenue bonds on behalf of Rockdale County, Georgia (the "County"), the Project is located in Rockdale County, Georgia, and within the jurisdiction of the Development Authority of Rockdale County, and the Board of Commissioners of Rockdale County, Georgia, constitutes the applicable elected legislative body of the County; and

WHEREAS, the final terms of the financing will be agreed upon by the Issuer, the Borrower and the purchaser of the Bonds; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Rockdale County, Georgia, and IT IS HEREBY RESOLVED by the authority of the same, as follows:

<u>Section 1</u>. Solely for the purposes of Section 147(f) of the Code, the issuance of the Bonds by the Issuer for the benefit of the Borrower in a principal amount not to exceed

\$83,000,000 to assist in the financing of the Project is hereby approved to the extent required by said Section 147(f) of the Code, as follows:

- (a) The Project consists of a multifamily housing apartment project to be known as Terraces at Fieldstone, totaling approximately 316 units in the aggregate, as more fully described above;
 - (b) The initial owner of the Project will be the Borrower, or an affiliate thereof;
 - (c) The Project is located in Rockdale County, Georgia; and
- (d) The maximum amount of tax-exempt obligations to be issued with respect to the Project is \$83,000,000.

Section 2. Such approval by the Board of Commissioners of Rockdale County does not constitute an endorsement to a prospective purchaser of the Bonds or the creditworthiness of the Borrower or the Project, and the Bonds shall not constitute an indebtedness or obligation of Rockdale County, the State of Georgia or of any county, municipal corporation or political subdivision thereof. The Bonds shall be payable solely from the revenues derived from the Borrower and pledged to the payment thereof and no owner of any of the Bonds shall ever have the right to compel any exercise of the taxing power of Rockdale County, said State or of any county, municipal corporation or political subdivision thereof, nor to enforce the payment thereof against any property of said County, State or of any county, municipal corporation or political subdivision.

Section 3. This resolution shall take effect immediately upon its adoption.
