RFQ #22-33 is hereby amended as follows:

## 1. Below are questions received and corresponding answers:

A. Question: Per Addendum No. 2 issued on October 20, 2022, answer to Question B "A single Project Manager can serve on both B.1 and B.2", can we provide only one two-page resume for B.1 and B.2 if we are proposing the same person for both roles? Are two separate Commitment Tables still required if we are proposing the same person for both Project Manager and Sr. Project Manager?

<u>Answer</u>: Yes, a single two-page resume for the same person is acceptable. Yes, two separate commitment tables will be required to demonstrate how the same person will be utilized across two roles.

**B.** <u>Question</u>: Per Addendum No. 2 issued on October 20, 2022, answer to Question C "These projects are essentially "twinned" and will need to have separate proposals/cover but should be submitted as a single package", is the County requesting two proposals bound together or two separate proposals bound separately but mailed in the same box/package? Furthermore, should the two proposals be submitted as one PDF or two separate PDFs?

<u>Answer</u>: Two separate proposals bound separately but submitted together in the same box/package. Two separate PDFs in the same email. If the file size is too large, then send multiple emails – note the email sequence (i.e., 1 of 2 and 2 of 2).
