All other terms and conditions remain in effect in accordance with the Agreement referenced in this Amendment.

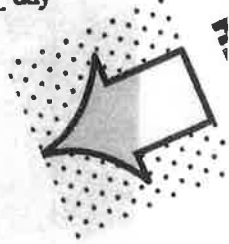

Youth Intervention Enrichment and Learning by Design

YIELD Delinquency Prevention and Violence Reduction Project

YIELD will provide long-term, ongoing, evidence-based INTERVENTION that includes decreased exposure to violence and mayhem through the provision of positive youth development assets in safe spaces, ENRICHMENT that includes establishing YIELD Ambassadors, hosting Hoops After Dark and conducting violence prevention classes that address bullying and harassment by peers, teen dating violence, school violence, and physical assault with or without weapons and LEARNING that creates college and career awareness in fields such as health and technology. The Contractor agrees to deliver professional services that meet the general scope of work required for YIELD Project as described here:

- Operate comprehensive afterschool and summer programming that expands and improves high quality learning and supports for K-12 students in Rockdale County.
- Combat learning loss, enhance students' well-being, connectedness, and mental health wellness.
- Directly support learning acceleration and whole child approaches to positive youth development.
- Prepare students for success in the present and ready students for new learning.
- Jump start underperforming students into learning new concepts.
- Create opportunities for struggling students to learn alongside their more successful peers.
- Acknowledge and address non-academic factors that impact academic outcomes
- Create environments where students are healthy, safe, engaged, supported, and challenged.
- Expand access to serve more youth, with an emphasis on those most impacted by the pandemic.

Change order is an increase of \$25,340 per awarded CJCC grant T18-8-009.

TERM OF CJCC grant: 10/01/2022 to 9/30/2023
