RFP #22-27 is hereby amended as follows:

- 1. Below are questions received and corresponding answers:
 - **A. Question**: The window muntin grid: Are they applied on exterior and interior surface of the glass and are they two (2) layers of glass?

Answer: Yes, they are applied on the exterior and interior on the first-floor bullet resistant as well as the 2nd and 3rd floor storefront option. On the vinyl option, there will be grills between the glass.

- **B.** Question: On the window storefront, is the aluminum frames for the windows thermally broken?
 - Answer: No. Thermal breaks are not required.
- C. Question: On the storefront entrance, is the aluminum storefront thermally broken?
 - Answer: No. Thermal breaks are not required.
- **D. Question**: On the storefront entrance, is the aluminum storefront ballistic rated? Advise on the required ballistic rating.
 - Answer: Yes. The entire assembly (frame and glass) shall be level 2 ballistic rated.
- **E. Question**: For the low "E" glass performance requirements, advise if you have a specific specification for the glass performance.
 - Answer: There is no bid specification follow window manufacturer's specification.
- **F.** Question: Is there a specification for the type low "E" required?
 - Answer: See answer above.
- **G. Question**: For Low "E" glass performance, advise the glass color that is required.
