RESOLUTION TO CREATE THE 2023 ROCKDALE COUNTY CITIZENS SPECIAL PURPOSE LOCAL OPTION SALES TAX (SPLOST) OVERSIGHT COMMITEE

WHEREAS, on May 24, 2022, the voters of Rockdale County approved a Special Purpose Local Option Sales Tax (SPLOST) to fund transportation projects, public safety projects and facilities, courthouse, parks and other needed improvements for the Conyers-Rockdale Community; and,

WHEREAS, the SPLOST will become effective in April 1, 2023 and remain in place for a period of six (6) years and generate an estimated \$89,100,000 in revenue; \$72,621,846 as the estimated portion for the County, and,

WHEREAS, citizen involvement has played a key role in the successful implementation of previous SPLOST programs in Rockdale County, including the 2017, 2011, 2005, 1999, 1996 and 1992 SPLOSTs; and,

WHEREAS, the Board of Commissioners desires to continue this beneficial relationship with an informed and involved citizenry,

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Rockdale County, Georgia, that the 2023 Citizens SPLOST Oversight Committee is hereby established and charged with providing input and oversight in an effort to assure that the 2023 SPLOST program is implemented in an expedient, organized and responsible manner.

BE IT FURTHER RESOLVED that the SPLOST Oversight Committee will consist of thirty-five (35) residents of Rockdale County. Committee members who shall serve at the pleasure of the Board of Commissioners throughout the implementation of the 2023 SPLOST program, shall create subcommittees, elect subcommittee chairs and establish a meeting schedule.

BE IT FURTHER RESOLVED that the Board of Commissioners hereby appoints members to the 2023 Citizens SPLOST Oversight Committee as set forth in Attachment "A" of this resolution, attached hereto and hereby made a part of this resolution.

BE IT FURTHER RESOLVED that any resolution in conflict with this resolution is hereby repealed.
