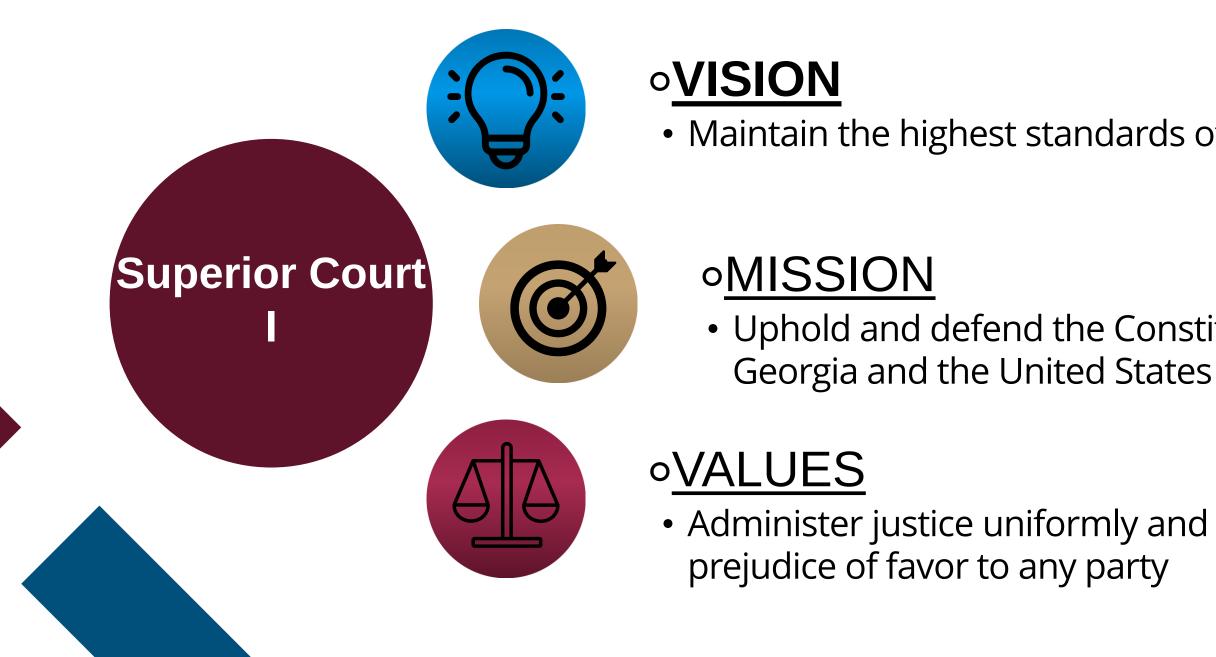

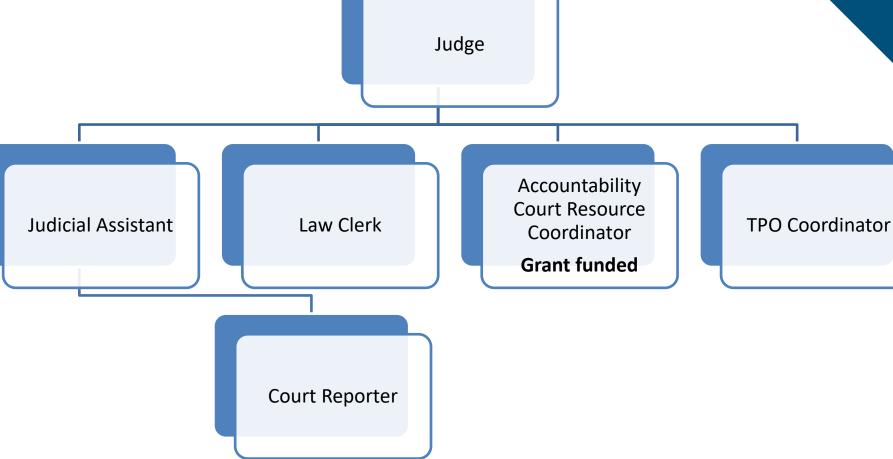

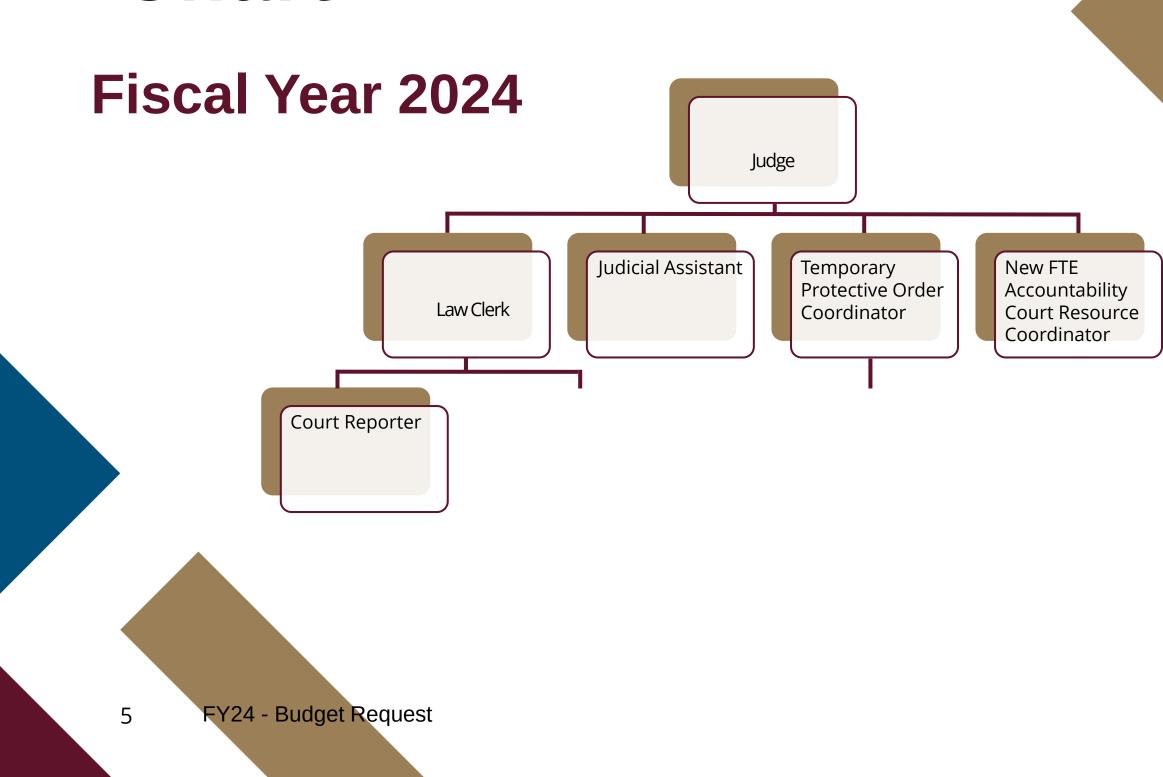
## **Current Organizational** Chart **Fiscal Year 2023**

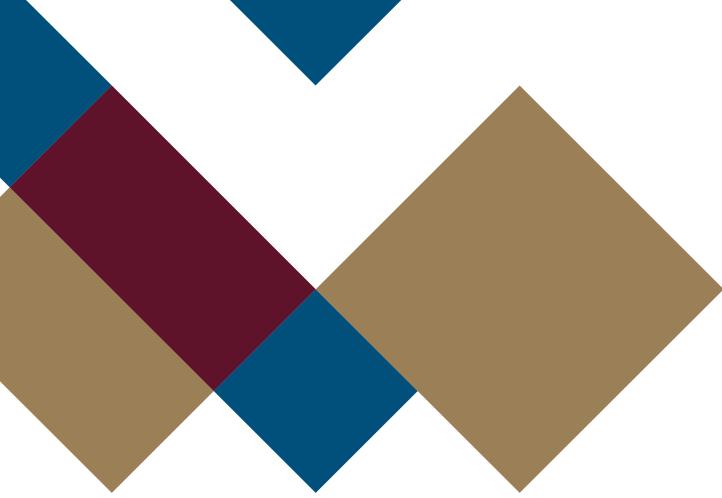

## Proposed Organizational Chart



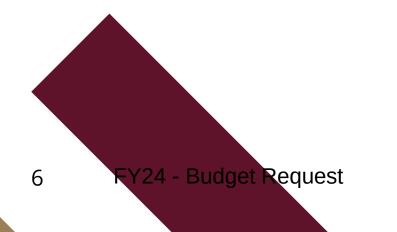
