## Addendum No. 2 RFP No. 24-07 FIRE UNIFORMS (REBID) August 30, 2024

RFP #24-07 is hereby amended as follows:

1. Below are questions received and corresponding answers:

**A. Question:** Why is it being rebid?

<u>Answer</u>: We re-bid this out due to some changes within the Scope of Work and/or Specifications that were not included in the original bid. We also changed it from an ITB to an RFP to use the Evaluation Criteria scoring system listed on page 6 of the RFP. The listed criteria are of importance to award this bid.

**B.** Question: Page 12 – Scope of Work - If all patches are included by the uniform supplier – why is there a need to provide pricing on bulk patches? Same as Item Number 22 on page 24.

<u>Answer</u>: While all the shirts and coveralls shall include the cost of patches within their unit price, there are times that bulk orders of patches are needed. Reasons for bulk patch ordering can include personnel changing ranks and additional patches needed for other gear and/or supplies.

C. Question: Quartermaster System – Is Rockdale Fire creating a quartermaster system and stocking product at their location or is Rockdale Fire requesting the uniform supplier to become the quartermaster and to hold this inventory? Also based on question under Item Number 17, it appears Rockdale is requesting that the dealer stock / supply all items with Rockdale not stocking any items. Is this correct?

<u>Answer</u>: The vendor is to create the Quartermaster system for Rockdale County Fire Rescue. We do not plan to hold bulk inventory. It is expected that the vendor would have most items in stock, ready to ship, when ordered.
