D. Question: Also, per pg. 11 under note #5, product to be Jar tested and Pilot tested. Can you please provide further information?

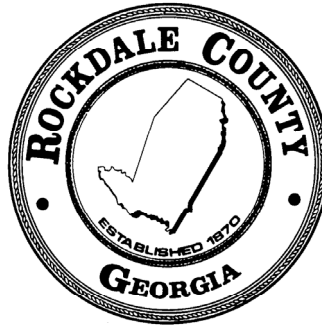
