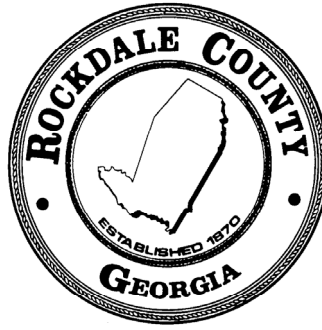

**Answer:** Please see attached. Current price is \$1.83 p/lb.

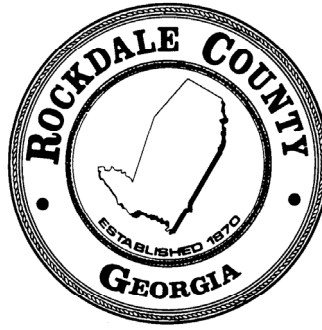
**D. Question:** Who should we work through to jar test and trial any of the products?
