Answer: The anticipated start date is December 2024.

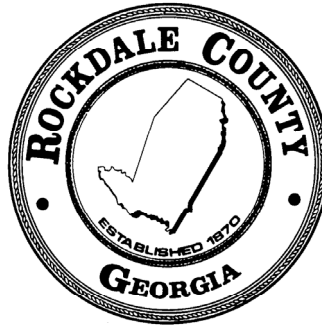
D. Question: When are the 1st orders expected for Blend Polyorthophosphate?

4. FIRST AID MEASURES
