WHEREAS, Rockdale County, Georgia has experienced an event of critical significance as a result of a chemical fire at the BioLab facility, commencing on the 29th day of September 2024 and is ongoing;

WHEREAS, there exist emergency circumstances requiring extraordinary and immediate corrective acts for the protection of the health, safety and welfare of the citizens of Rockdale County, Georgia, and;

WHEREAS, to prevent or minimize injury to people and damage to property resulting from this event; now

THEREFORE, Rockdale County, Georgia hereby declares that a local state of emergency exists.

IT IS HEREBY ORDERED that the Rockdale County Emergency Management Agency activate the County Emergency Operations Plan, and,

IT IS FURTHED ORDERED that the emergency management ordinances adopted by the Rockdale County Board of Commissioners become activated until such time declared by the Rockdale County Emergency Management Agency.
