

A RESOLUTION AUTHORIZING THE CHAIRMAN OF THE BOARD OF COMMISSIONERS OF ROCKDALE COUNTY TO EXECUTE CONTRACTS WITH ANTHEM BLUE CROSS BLUE SHIELD, KAISER PERMANENTE, AETNA, DELTA DENTAL, AND UNUM.

WHEREAS, the Board of Commissioners of Rockdale County, Georgia, have entered into an agreement with Anthem Blue Cross Blue Shield, Kaiser Permanente, Aetna, Delta Dental, and UNUM in order to provide health and wellness benefits to the employees and retirees of Rockdale County, and

WHEREAS, the Board of Commissioners of Rockdale County, Georgia desire to ensure the efficient and uninterrupted benefits to all employees, and

WHEREAS, Anthem Blue Cross Blue Shield, shall provide major medical and vision insurance. Kaiser Permanente shall provide major medical. Aetna shall provide Medicare Advantage for Rockdale County's retirees. Delta Dental shall provide dental insurance. Unum shall provide life and disability.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Rockdale County the Chairman of the Board of Commissioners shall be authorized to execute contracts directly related to the existing health coverage and voluntary agreements with Anthem Blue Cross Blue Shield, Kaiser Permanente, Aetna, Delta Dental, and UNUM. These contracts shall be subject to review by the Rockdale County Attorney.
