AMENDMENT NO. 1 to the Citizen Request Management (CRM)
Notifications & Alerts Agreement dated January 23, 2024

This CONTRACT AMENDMENT, made and entered into by and between ROCKDALE COUNTY, GEORGIA, hereinafter called the "County" or "Customer", and GOGOV, INC., hereinafter called the "GOGov", shall be incorporated into and become a part of the original Agreement cited immediately above.

WHEREAS, the parties previously agreed, pursuant to the Agreement to amend the contract as needed, and;

WHEREAS, a need to amend the contract has arisen.

NOW, THEREFORE, for and in consideration of the covenants and promises to be carried out by each party herein and in the original Agreement cited above, it is agreed by and between the parties as follows:

- 1. Increase pricing from \$14,976 annually to \$16,020 annually (includes Bundle discount) in accordance with GOGov's September 11, 2024 Quote attached hereto and made a part hereof.
2. Renew contract term through February 28, 2026.

All other terms and conditions remain in effect in accordance with the Agreement referenced in this Amendment.
