AMENDMENT NO. 2 to Agreement for
Prehire Reference Checks, dated October 12, 2021

This CONTRACT AMENDMENT, made and entered into by and between ROCKDALE COUNTY, GEORGIA, hereinafter called the "County", and CROSSCHQ, INC., hereinafter called the "Contractor", shall be incorporated into and become a part of the original Agreement cited immediately above.

WHEREAS, the parties previously agreed, pursuant to the Agreement to amend the contract as needed, and;

WHEREAS, a need to amend the contract has arisen.

NOW, THEREFORE, for and in consideration of the covenants and promises to be carried out by each party herein and in the original Agreement cited above, it is agreed by and between the parties to modify the Agreement as follows:

1. Increase price from \$4,950 per year to \$5,196 per year, total \$10,392 for twenty four (24) months.
2. Renew contract term for twenty four (24) months through October 12, 2026.

All other terms and conditions remain in effect in accordance with the Agreement referenced in this Amendment.

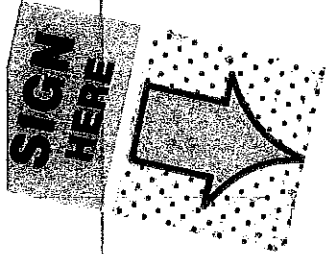
