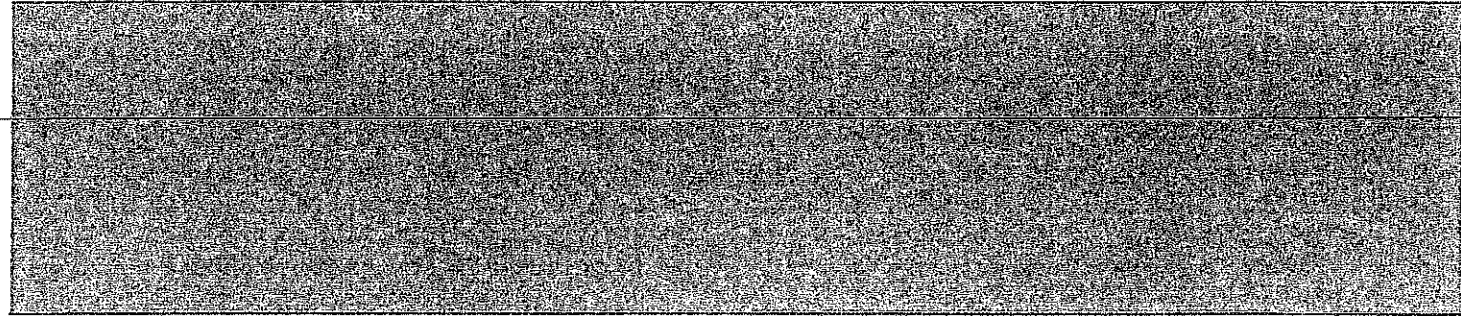

Detailed Summary of Contract:
 The Code Enforcement Division is awarded a grant in partnership with the City of Conyers for \$10,000 in BRACE (Blight Reduction and Code Enforcement Efforts) Grant funds from the Keep Georgia Beautiful Foundation. Funding will be provided to KGBF by the Solid Waste Trust Fund.

The grant funds will be utilized to host a Love Where You Live community clean-up event in Spring 2025. Residents will be able to drop off trash, tires, and electronics for one day at a central location in the County. Residents will also be given educational materials on the County's Code of Ordinances. A "Keep it Clean" kit will also be provided to the first 100 participants. The kit will include tips to create their own neighborhood cleanup, trash bags, a 5-gallon bucket, and a picker.

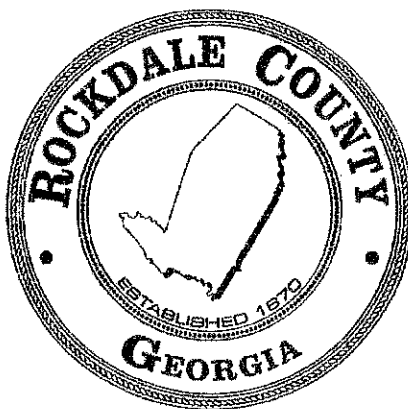

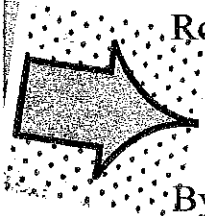
