AMENDMENT NO. 3 to the Agreement for Contracted Legal Services dated December 13, 2022

This contract amendment, made and entered into by and between ROCKDALE COUNTY, GEORGIA, hereinafter called the "County", and Giget Johnson, Attorney at Law hereinafter called the "Contracted Attorney", shall be incorporated into and become a part of the original Agreement cited immediately above.

NOW THEREFORE, the County and the Contracted Attorney agree to amend the Agreement as follows:

- 1. Contract, Item 2, Term: Delete last sentence that reads "This Agreement has two (2) one year options to renew, renewable each year for a twelve months period." and replace with "This Agreement has two (2) two-year options to renew, renewable every two years for a twenty-four (24) month period."
 - 2. Renew contract term two (2) years through December 31, 2026.

All other terms and conditions, including previous Amendment Nos. 1 & 2, shall remain in effect in accordance with the Agreement referenced in this Amendment.
