


AMENDMENT NO. 1 TO THE  
AGREEMENT FOR PROVIDING CONTRACTED SERVICES FOR SCADA SUPPORT

This CONTRACT AMENDMENT, made and entered into by and between ROCKDALE COUNTY, GEORGIA, hereinafter called the "County", and AUTOMATED INTEGRATION, LLC, hereinafter called the "Contractor", shall be incorporated into and become a part of the original Agreement cited immediately above.

WITNESSETH:

**WHEREAS**, the Parties previously entered into that certain Agreement for Water Resources Control Systems Analyst/SCADA Manager Employment support services dated October 26, 2021 (the "Agreement");

**WHEREAS**, the Parties now desire to amend the Agreement in the manner set forth herein;

**NOW, THEREFORE**, for and in consideration of the covenants and promises to be carried out by each party herein and in the original Agreement cited above, it is agreed by and between the parties to amend the terms of the Agreement as follows:

Delete Section 6 currently in contract and replace with the below provision.

This Agreement is effective November 27, 2024, and shall continue through November 26, 2025, and is renewable for two (2) additional one-year terms, unless terminated as provided in Section 5 of the contract.

All other terms and conditions remain in effect in accordance with the Agreement referenced in this Amendment.
