AN ORDINANCE TO AMEND THE FUTURE LAND USE MAP OF ROCKDALE COUNTY'S COMPREHENSIVE PLAN, AS AMENDED, FOR PROPERTY LOCATED AT 1362 AND 1390 NW ROCKBRIDGE ROAD FROM THE LOW DENSITY RESIDENTIAL FUTURE LAND USE CATEGORY TO THE LIGHT INDUSTRIAL FUTURE LAND USE CATEGORY; TO REPEAL CONFLICTING ORDINANCES AND FOR OTHER PURPOSES.

WHEREAS an application to amend the Future Land Use Map of Rockdale County's Comprehensive Plan for a certain property was filed with Rockdale County, Georgia, which involved the following:

Section I

The Future Land Use Map of Rockdale County's Comprehensive Plan, as amended, is hereby further amended to change the 47.72-acre property, located at 1362 and 1390 NW Rockbridge Road and more particularly described in the Legal Description attached hereto as Exhibit "A" and depicted on Exhibit "B" attached hereto, from the Low Density Residential Future Land Use Category to the Light Industrial Future Land Use Category.
